GENERAL GUIDELINES

- **WORK.** You can send up to 3 works to be considered. We require **4 images** (at minimum) of each work. All submitted work must have been created within the last 3 years. If you are currently developing the work please send us whatever you have to help us understand your project. Artists working in the medium of video or multimedia are advised to provide a link to preview videos of previous and/or ongoing work. Videos can be supplemented with up to 4 digital images. Videos may be no longer than 30 minutes. We do not accept feature-length films.
- **ARTIST PHOTO.** Please send at least **1 images** of you (working and/or with your work).
- **FORM.** Please fill out the appropriate form (*Individual, Group*).
- **FOLDER.** Include your submission in a folder with the following title format: "submission+ artist's full name".

IMAGE SPECIFICATIONS

Images should be in uncompressed .JPG or PNG with high resolution enough to fit across about 1000 pixels without blurring. All images must be listed with slide number, artist's last name, title of work and year, eg. 1_smith_untitled_2009.jpg

If needed you can send files through a transfer service like WeTransfer or G-Drive.

POLICY FOR WORKS

The artists who fill out the Application Form thereby certify that they are the sole owners of the economic rights to the works submitted and that the projects are not encumbered by third-party rights.

Once your work has been sent, you are entering into an agreement that grants Snow Cannon the rights to study the proposal and handle your private data.

INFORMATION CLAUSE

1. Snow Cannon team, with the purpose of studying and handling your proposal, will administer your personal data.

2. You provide your data voluntarily, but the provision of data is required if you wish Snow Cannon to review your work.
3. You have the right to:
 - a. access your personal data, correct them, remove them, or restrict their use,
 - b. transfer your data,
 - c. object to the processing of your data
4. Your data will be processed based on the consent you have granted; you are entitled to withdraw your consent at any time, without any effects for the legality of data processing before the withdrawal. A declaration of withdrawal may be sent by e-mail to snowcannon.mail@gmail.com.
5. Your personal data will be processed for a period necessary to achieve the above-mentioned objectives.
6. Your personal data will not be processed in an automated manner or subject to profiling.

CONSENT TO THE PROCESSING OF PERSONAL DATA

You consent that your personal data is processed for the purpose or being analyzed by Snow Cannon team.

Your Personal data shall be processed for the duration of 1 year from the submission date. After this period, Snow Cannon shall see to the proper deletion of your Personal data.

The provision of personal data is voluntary, but required in order to achieve the objective for which the data are collected.
